

## 1. Terms of Use and Privacy Policy

1.1. When accessing or using the website of the "CONAD2021" ("CONAD2021" or "Site"), including the content and applications available on the Site and other domains used to operate the CONAD2021, the one who accesses or uses the Site ("User") declares to have read and understood these Terms of Use ("Terms"), as well as fully and expressly agreed with them and is obliged to strictly comply with the conditions set forth herein, forming a contract between the User and the Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America.

1.2. The User declares to be of legal age and capable, having full conditions to adhere to and be bound by the conditions of these Terms.

1.3. If the User does not understand or agree to any provision of these Terms (in whole or in part) or does not have the legal capacity to contract, in his own name, the User shall immediately leave the conad2021.org/, close the tab or window of the Internet browser you are using to access it and refrain from accessing or using, in any way, the conad2021.org/.

1.4. The User acknowledges and agrees that all notices, regulations of use, policies and instructions presented in the conad2021.org/, especially the Privacy Policy, are part of these Terms as if they were transcribed therein.

1.5. A Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America may modify these Terms at any time, and the User, by accessing and/or using the conad2021.org/, express your consent and complete agreement to comply with such modifications or revisions. The User shall periodically reread the current version of this instrument (available at the URL <https://www.conad2021.org//>), even though the Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America always seek to keep you informed of important changes made to these Terms.

1.6. This Term shall enter into force at the time of first access or use of the conad2021.org/ will remain in effect for the period necessary for the integrated compliance with these Terms.

### 2. Account in the conad2021.org/

2.1. The provisions of this clause 2 shall apply where the conad2021.org/ make available to Users an account for access to the restricted area or for certain features of the Site.

2.2. The User may create an account to have a more personalized experience on the Site. Access credentials, including login and password, are personal and non-transferable.

2.3. When creating an account, the User declares that the information provided is correct, complete, current and true. 2.6. ### 3. Use of [conad2021.org/](http://conad2021.org/)

3.1. A Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America personal, non-exclusive and non-transferable permission to the User to access and use the [conad2021.org/](http://conad2021.org/) legally, having access to the entire collection of images, illustrations, audios, audiovisuals, texts, applications, databases and other materials available in the [conad2021.org/](http://conad2021.org/) ("Content"). On the other hand, the User undertakes not to:

(a) reproduce or in any way copy, transmit, exploit or distribute the Contents of the conad2021.org/, in whole or in part, for any purpose (including text, images and other materials), without the prior written permission of the Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America;

conad2021.org/ at any time, without the need for prior information to anyone.

3.3. Links to external websites that may be mentioned in the Conad2021.org/ do not represent any kind of endorsement of those external websites or their content by the Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America. Any access to or use of these external websites by the User will be made at your own risk. ## 6. Responsibilities and Guarantees

6.1. 7.3. These Terms and any rights limited to the use of the Content granted herein may not be transferred or assigned by you, but may be transferred,

assigned or revoked by the Convenção Fraternal dos Ministros da Assembleia de Deus nos Estados Unidos da America, without any restriction.7.4.
